Furthermore, OCUL, the Duke Energy Convention Center, and Geo. E. Fern Co., their agents or employees, shall not be responsible for any loss, theft or damages to the property of the Exhibitor, his or her employees or representatives. In addition, OCUL, the Duke Energy Convention Center, and Geo. E. Fern Co. will not be liable for injury to persons during the term of the OCUL Convention from any cause whatsoever by reason of the use of occupancy of the convention/exhibit space by the Exhibitor or representatives. The Exhibitor shall indemnify and hold harmless OCUL, the Duke Energy Convention Center, and Geo. E. Fern Co. from all liability which might ensue from participation in the convention. See the following Rules and Regulations.

The Ohio Credit Union League is the trade association for credit unions in Ohio. The Ohio Credit Union League desires to allow Vendors that offer products and services of interest to credit unions to participate in the Ohio Credit Union League ZENITH10 expo hall. NOW, THEREFORE, in consideration of the foregoing and the respective representations, warranties, covenants, agreements and conditions hereinafter set forth, and intending to be legally bound hereby, the parties hereto agree as follows:

Vendor agrees to carry out its activities hereunder in a lawful and businesslike manner. Vendor shall indemnify OCUL from and against any and all liability, loss, or damage suffered by OCUL as a result of any claim, demand, suit, costs or judgment against it (including attorney's fees) arising out of any breach of this Agreement by, or the negligence or willful act or omission of Vendor.

OCUL, at its discretion, reserves the right to determine if the Exhibit Booth or exhibit, as well as the products, services, or goods and presentations, are not appropriate and must be removed, changed, or modified. Failure to comply will result in restrictions on the Exhibit, whether actual or virtual, up to and including eviction or removal in whole or in part. OCUL is not obligated to refund any fees associated with the Exhibit for such action.

If any provision of this Agreement is or becomes void or unenforceable by force or operation of law, the other provisions shall remain valid and enforceable. To the extent that the provisions of the ZENITH10 Rules and Regulations are not consistent with the provisions of this Agreement, the provisions of this Agreement will prevail.
